NOTICE OF PREPARATION OF A PRELIMINARY ENVIRONMENTAL ASSESSMENT COMPTON UNIFIED SCHOOL DISTRICT COMPTON HIGH SCHOOL RECONSTRUCTION PROJECT

The Compton Unified School District ("District") would like to provide you with notice of the preparation of a Preliminary Environmental Assessment ("PEA") that was conducted for the Compton High School Reconstruction Project at Compton High School located at 601 South Acacia Avenue and south adjoining properties, 301 W. Alondra – 339 W. Alondra, along West Alondra Boulevard, California.

A licensed contractor, working on behalf of the District, performed the environmental investigation under the regulatory oversight of the California Department of Toxic Substances Control ("DTSC"). The environmental investigation consisted of the sampling of soils for hazardous materials, including organochlorine pesticides (OCPs), lead, petroleum hydrocarbons (PHs), and volatile organic compounds (VOCs).

Results of the PEA have been submitted to the District and DSC in a report for review. The report includes an assessment of whether OCPs, lead, Phs, and VOCs are present at concentrations that would require further assessment or a response action before the site is cleared for construction activities. A draft of the PEA report, any changes requested by DTSC for the PEA, and any correspondence between the District and DTSC relating to the PEA will be available for public review and comment period between May 11, 2020 and June 10, 2020. These documents will be available for public review at the District office at 501 S. Santa Fe Avenue, Compton, California 90221, by appointment only, and subject to CDC Guidelines in response to COVID-19.
